Post-Placement Fees	MAA Post Adoption Supervision	\$350 per report	Paid to MAA if post-adoption provider; 4 reports required.	
Post-Placement Fees	Post Adoption Bond	\$1000	Paid if MAA is NOT provider; Bond is refunded after all 4 reports are received.	
USCIS Fees	Medical Exam & Vaccinations	\$200 - \$500	Paid to approved provider in Bulgaria	During 2 nd Trip
USCIS Fees	Visa for Child	\$404	Fee for child to obtain a US Visa.
