CHINA PROGRAM: SCHEDULE AND CONFIRMATION OF ADOPTION COSTS

Madison Adoption Associates has received your application for adoption. We request that you confirm the program costs by signing and returning this letter. We will begin to process your paperwork when it is received. Thank you.

Fee Categories. In accordance with Hague regulations, all adoption fees are identified by the following categories:

- **Agency fees** include, but are not limited to, personnel costs, administrative overhead, operational costs, training and education, communications and publications costs, and any other cost related to providing adoption services in the United States.
- **Foreign country expenses** include, but are not limited to, costs for personnel, administrative overhead, training, education, legal services, communications, and any other costs related to providing adoption services in China.
- **Care of the Child** (in China prior to adoption) include, but are not limited to, costs for food, clothing, shelter, and medical care; foster care; orphanage care; and other services provided directly to the child.
- **Translation and document expenses** include, but are not limited to, costs for obtaining, translating, or copying records or documents required to complete the adoption; costs for the child's China court documents, passport, adoption certificate, and other documents related to the adoption; and cost for notarizations and certifications.
- **Charitable Development fee** is a fixed contribution amount that goes directly to child protection or child welfare services programs run by MAA. MAA also contributes a portion of the fees collected for Home Studies and for Agency Placement Fees to charitable aid. MAA has provided aid to orphanages and schools in Guatemala, supplies to orphanages in China, as well as various projects worldwide.

TP = Traditional Program **WC** = Waiting Child Program

SF= Special Focus Program **SFD**= Special Focus Program using Previous Dossier

Grants will be deducted from agency fees that are due with submission of the dossier. It is part of MAA's mission to provide grants to help place children in need. If an MAA camp child is also classified as Special Focus (SF), MAA will give the adopting family the greater of the two grants available. SF grants will not be given in addition to other substantial grants.

Some fees are a reasonable estimate; actual costs vary depending on circumstances including time, location, duration, etc. All fees are subject to change and any fees not paid to MAA are not under the control or discretion of MAA.

The fees charged for authenticating a family's dossier includes all third party carriers, fees and domestic couriers. If a family completes their own dossier authentication, they must provide MAA with original set and two sets of copies. If MAA has to copy family's dossier, an additional \$200 fee will be charged for time and expense.

On occasion, MAA may be able to offer monetary grants based on a child's special needs and a family's financial situation. Please ask us for details and an application.

ADOPTION-RELATED EXPENSES (ESTIMATES ONLY)-

The fees set forth above do not include ALL various adoption-related expenses that the Adoptive Parent(s) pay directly to third parties. These expenses include, without limitation travel costs, which vary considerably with the season and amount of time available to make travel plans; Home Study (for out-of-state clients); or certification/authentication fees charged by other parties, which can vary greatly from state to state. While MAA's U.S. stateside agency fees will not change during your adoption, all other fees, including foreign program fees are subject to changes beyond our agency's control. The costs of any of these expenses are in the control of third parties over whom MAA has no control, and, therefore, the costs could change at any time. MAA assumes no liability if the actual cost of any of the expenses estimated therein exceeds estimates.
